**Information clause**

Pursuant to Art. 13 of the General Data Protection Regulation of 27 April 2016 (Journal of Laws UE L of 2016 No. 119) hereinafter referred to as GDPR, I would like to inform that:

Żywiecka 92/4, 43-300 Bielsko-Biala with the annotation "GDPR" **[Purposes of data processing]** Your personal data will be processed in connection with your participation in the Polish Championship Garmin Enduro Trails 2022 ("Competitions"), (ii) for the purposes necessary to fulfil the legal obligations incumbent on the Administrator, in particular those resulting from tax law and accounting regulations; (iii) for purposes resulting from the legitimate interests pursued by the Administrator, in particular to ensure contact with you before, during and after the Competition and to establish, investigate or defend against any claims and promote the Competition and media coverage of the Competition by both the Administrator as well as cooperating entities, (iv) in connection with your consent..
3. **[Legal grounds for processing personal data]** Legal grounds for processing your personal data: (i) Article 6(1)(a) GDPR (ii) Article 6(1)(b) GDPR; (iii) Article 6(1)(c) GDPR, Article 6(1)(f) GDPR.
4. **[Recipients of personal data]** The recipients of your personal data – only in cases where it is necessary and to the extent necessary – may be entities cooperating with the Administrator in the field of services provided to the Administrator and supporting the Administrator's current business processes, in particular entities providing IT services and marketing services, legal, courier, banks.
5. **[Period of personal data processing]** Your personal data will be processed for the duration of the Proceedings, and after this period for the duration of the concluded contract (concluded as a result of the Proceedings), and then for the period of limitation of any claims resulting from generally applicable provisions of law. If the processing is necessary to fulfil the legal obligation incumbent on the Administrator, your personal data will be processed for the period resulting from generally applicable legal provisions, in particular tax law and accounting regulations. If the processing is necessary for the purposes of the legitimate interests pursued by the Administrator or by a third party, your personal data will be processed for a period not longer than it is necessary for the purposes for which the data is processed or until you object to the processing of such personal data.
